Agreement between User and saturnnft.io

Welcome to saturnnft.io. The saturnnft.io website (the "Site") is comprised of various web pages operated by Ganivar, LLC ("Ganivar"). saturnnft.io is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of saturnnft.io constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

saturnnft.io is an E-Commerce Site.

Saturn allows users to create NFTs on the Cardano Blockchain and allows supporters of an NFT project to mint the NFT through the Saturn payment gateway. Saturn allows a user to create custom images and organize their collection before release and allows users to edit their blockchain metadata in a simple and intuitive user interface.

The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER.
